




Origin of Comprehensive Approach

Goal: Prevent future victimization

- Multidisciplinary team approach
- Specialized training
- Outcome evaluation drives program modification

What level of collaboration is there between offender management and victim services?

- We are aware of each other's programs but do not work together.
- We work together on certain cases but don't consistently collaborate.
- We coordinate all offender management and victim services.
- We don't know what each other does.

What should be done in order to manage offenders effectively?





"What is in the best interest for the safety of the victim and the public?"







Public Education

Empower them to be part of the solution










Monitoring and Evaluation




