#### Office for Victims of Crime Training and Technical Assistance Center (OVC TTAC): Financial Management Training

To serve crime victims more effectively, victim service organizations must use fundamental financial management practices to stay solvent and operate properly. This <u>training</u> provides an introduction to basic financial management practices. You will learn key bookkeeping and accounting principles, how to prepare financial documents, how to prevent fraud, and the differences in available financial management tools. This training will be delivered online, over the course of 6 weeks, beginning on August 31, 2020. Application for this training opens on August 10, 2020. Each week, except for the introductory week, will include a facilitated webinar. There are recommended readings and videos, as well as written assignments. You should expect to spend about an hour per week on these assignments, in addition to attending the 75-minute webinar. CEUs will be awarded for those who complete all requirements. Please note: Space is limited.

# **OVC Special Feature: Learn more about the upcoming transition to new grants and payment management systems...**

The transition to the Justice Grants System (JustGrants) and the Automated Standard Application for Payments (ASAP) is just months away. Beginning on October 15, JustGrants will replace the Grants Management System (GMS) currently used by OJP and OVW, as well as the NexGen system used by the COPS Office. At the same time, ASAP will replace the Grants Payment Request System (GPRS).

## Automated Standard Application for Payments (ASAP)

ASAP registration will take place throughout July and August. Registration emails will be sent to your organization's SAM Electronic Business Point of Contact (E-Biz POC). Once you receive the email, refer to the

You have 45 days to complete all enrollment steps. If you do not complete all steps within the 45-day timeframe, you must start from the beginning.

#### **Grants Management and Payment Systems**

The current systems—GMS, NexGen, and GPRS—will be discontinued beginning September 22, 2020. At this time, data, and attachments for all current active awards from GMS and NexGen will be migrated to JustGrants. This includes all open, active awards and any awards that have not been programmatically and fiscally closed. All award management activities will take place in JustGrants beginning on October 15, 2020. Users will not have access to GMS, NexGen, or GPRS after September 22.

#### **Key Transition Activities**

In the weeks leading up to the October 15 transition, there are several actions current award recipients will need to take. Key dates for these actions are provided at the links below:

#### **Important Dates**

- July-August 2020 Current grantees receive instructions on how to enroll in the ASAP system.
- **Early August 2020** Current grantees receive instructions on how to access the JustGrants external dashboard and register in the system.
- August 21, 2020 JustGrants will open for external grantee organizations to enroll users.
- August–October 2020 Training will be available to external users through web-based e-learning courses, job aids, and virtual Q&A sessions. Additional information will be forthcoming.
- September 22, 2020 Legacy systems, including GMS, NexGen, and GPRS, are discontinued.
- September 23–October 14, 2020 Final data migration and "cutover" activities from the legacy systems to JustGrants occur.
- October 15, 2020 JustGrants is launched and grantees begin using the ASAP system.

#### <u>Office of Justice Programs (OJP) Blog Post: Celebrating 50 Years of American Indian Self-Determination</u> By Principal Deputy Assistant Attorney General Katharine T. Sullivan

"Today marks a milestone in relations between the federal government and Indian nations. Fifty years ago, today, President Richard M. Nixon delivered a special message to Congress announcing a new era of self-determination for American Indian tribes. 'The time has come to break decisively with the past,' he said, 'and to create the conditions for a new era in which the Indian future is determined by Indian acts and Indian decisions.'" #### <u>Presidential Task Force on Missing and Murdered American Indians and Alaska Natives Virtual</u> Consultations

On November 26, 2019, President Trump signed Executive Order 13898, forming the Task Force on Missing and Murdered American Indians and Alaska Natives (AI/AN). The Executive Order requires the Task Force to "conduct

appropriate consultations with Tribal governments on the scope and nature of the issues regarding missing and murdered AI/AN." While the Task Force had plans in place for a robust schedule of consultations and listening sessions in various locations in Indian country and elsewhere beginning in March, the sessions were postponed due to the current public health crisis. The Task Force has instead established a series of virtual Tribal consultations. The sessions are based on Bureau of Indian Affairs regions. The session schedule and registration information are located here.



#### <u>Consultation Framing Paper on the Juvenile Justice Reform Act and Tribal Youth Delinquency Prevention</u> <u>and Intervention Programs</u>

Through this consultation, the Office of Juvenile Justice and Delinquency Prevention (OJJDP) is <u>seeking input</u> on how it can collaborate with tribes to implement applicable provisions of the Juvenile Justice Reform Act (JJRA). OJJDP seeks to increase tribes' awareness of and access to juvenile justice funding. This consultation will be conducted remotely via webinar. In addition, OJJDP is accepting written comments at <u>OJJDPTribalConsultation@ojp.usdoj.gov</u>.

## A Children's Storybook - Our smallest warriors, our strongest medicine: Overcoming COVID-19

This children's storybook is a re-telling of <u>My Hero is You</u>, developed by the Inter-Agency Standing Committee Reference Group on Mental Health and Psychosocial Support in Emergency Settings (IASC MHPSS RG). An intertribal workgroup convened to re-write this story and create illustrations that represent Indigenous peoples, values, and communities. The adapted story seeks to reach Indigenous peoples across Turtle Island and portray a sense of communal efficacy, strength, and hope in the face of the COVID-19 pandemic. This project was funded by the Johns Hopkins University (JHU) Alliance for a Healthier World and the JHU Office of the President and Office of the Provost. #### Meeting the Needs of American Indian and Alaska Native Survivors with Disabilities Webinar

Over the last decade, great strides have been made to address violence against people with disabilities in communities across the country. However, many mainstream organizations may be less equipped to provide accessible, culturally responsive services to American Indian or Alaskan Native (AI/AN) survivors with disabilities. 2.9 million people in the United States identify as "American Indian or Alaskan Native" (2010 U.S. Census). People in AI/AN communities are more likely to experience domestic violence and sexual assault and have high rates of disability. Mainstream organizations need to know how to meet their unique needs in a culturally responsive way. During this End Abuse of People with Disabilities webinar, Amanda Watson, Program Director at Praxis International, will explore ways in which programs can better understand the cultural implications of working with AI/AN survivors with disabilities and provide guidance on strategies for best serving them. **Event Date**: August 25, 2020 | 2:00-3:30 pm ET. **Register** here.

#### Introductory Webinar on Mass Violence Response for Tribal Communities

The National Mass Violence and Victimization Resource Center (NMVVRC), in collaboration with Unified Solutions, is hosting an introductory webinar on mass violence response for Tribal communities. This free webinar will highlight the experience of Tribal members who responded during the Red Lake Band of Chippewa Indians mass violence incident, federal law enforcement response to that incident, and provide resources and information to Tribal victim services providers designed to assist them in developing victim-centered mass violence response plans.



#### Become a Positive Indian Parenting Trainer at the Virtual September Training Institute

Positive Indian Parenting is an eight-week curriculum developed by the National Indian Child Welfare Association (NICWA). The training helps parents explore the values and attitudes expressed in traditional AI/AN child-rearing practices and apply them to modern parenting. The curriculum draws on the strengths of traditional Indian parenting practices using storytelling, cradleboard, harmony, lessons of nature, behavior management, and the use of praise. It also addresses the historic impact of boarding schools, intergenerational trauma and grief, and forced assimilation on parenting.

#### Federal Indian Law Course Online

A team of faculty and staff from the Indigenous Peoples Law & Policy Program and the Native Peoples Technical Assistance Office designed the course "Federal Indian Law and Policy: Tribal Sovereignty and the Legal Relationship Between Tribes and the United States" for tribal leaders, attorneys, college students, and anyone with an interest in learning about the history and development of Federal Indian Law. #### Accessing Grants to Strengthen Justice System Capacity Workshop Parts 1 and 2

The Department of Justice launched its Coordinated Tribal Assistance Solicitation (CTAS) in direct response to concerns raised by tribal leaders that DOJ's grant process did not provide the flexibility tribes need to address their criminal justice and public safety needs. In Fiscal Year 2019, the department awarded over \$273.4 million in grants to improve public safety, serve victims of crime, combat violence against women and support youth programs in American Indian and Alaska Native communities. The awards included more than \$138 million for 149 American Indian tribes, Alaska Native villages, tribal consortia and tribal designees under CTAS.



Tribes are using these funds to enhance law enforcement, combat domestic violence, dating violence, stalking and sex trafficking, bolster justice systems, prevent and control juvenile delinquency, strengthen the juvenile justice system, serve sexual assault and elder victims, and support other efforts to address crime. Additionally, FY19 included up to \$133 million to be used to serve tribal victims of crime.

This workshop is designed to provide previous and new CTAS applicants with tools and guidance that may assist with the tribe's efforts to access grant funding and other resources to improve their justice systems. Workshop sessions will be led by DOJ personnel and experienced technical assistance providers and will focus on topics such as: 1) strategic planning to support a strong program design; 2) writing a proposal; 3) grant writing tips; and 4) DOJ funding opportunities and training and technical assistance resources.

#### <u>OVC FY 2020 Antiterrorism and Emergency Assistance Program (AEAP) for Crime Victim Compensation</u> and Assistance

The Antiterrorism and Emergency Assistance Program (AEAP) is a mechanism by which the Director of OVC may award supplemental crime victim compensation and assistance to respond to an act of domestic terrorism or mass criminal violence. The criminal act has to be of sufficient magnitude that the jurisdiction cannot provide needed services to victims of the incident with existing resources and it places an undue financial hardship on the jurisdiction's ability to respond to victims of other crimes in a timely and comprehensive manner. This is not a competitive solicitation.

The Federal Transit Administration (FTA) announces the availability of approximately \$5 million in funding provided by the Public Transportation on Indian Reservations Program (Tribal Transit Program (TTP). This is a national solicitation for project proposals and includes the selection criteria and program eligibility information for Fiscal Year 2020 projects. The primary purpose of these competitively selected grants is to support planning, capital, and, in limited circumstances, operating assistance for tribal public transit services. Funds distributed to Indian tribes under the TTP should not replace or reduce funds that Indian tribes receive from states through FTA's Section 5311 program.

#### Healthy Homes Production (HHP) Grant Program for Tribal Housing

The purpose of the HHP program is to assist AI/AN tribal government to identify and remediate housing related health and safety hazards. HHP is part of HUD's overall Healthy Homes Initiative launched in 1999. The program takes a comprehensive approach to addressing multiple childhood diseases and injuries in the home by focusing on housing-related hazards in a coordinated fashion, rather than addressing a single hazard at a time. The program builds upon HUD's experience with Lead Hazard Control programs to expand the Department's efforts to address a variety of high-priority environmental health and safety hazards.
