His responsibilities included specialized training in the treatment, containment, and management of high risk offenders and oversight

for approximately 350 high risk offenders. Greg also trained and provided field forensic computer examinations and installation of monitoring software for sex offenders in Boulder County. He coordinated services with professionals managing high risk offenders and develops private and public collaborations. Greg has provided training and consultation services to the National Institute of Corrections, The National Law Enforcement and Corrections Technology Center, The Colorado Division of Criminal Justice, The Colorado Sex Offender Management Board and he has served on numerous committees charged with developing or enhancing sex offender standards in Colorado. Greg is also the president of ERB consulting, a company providing training in the management of high risk offenders, specialized sex offender treatment and supervision field computer forensics and monitoring, leadership development, and grant writing.
