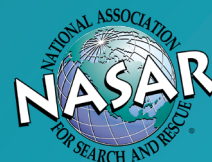
Missing and Unidentified Persons Conference

The sheer volume of missing and unidentified person cases poses one of the greatest challenges to agencies tasked with resolving these important cases. As of December 31, 2020, the FBI's National Crime Information Center (NCIC) contained 89,637 active missing persons records. Juveniles under the age of 18 account for 30,396 (34 percent) of the records and 38,869 (43 percent) of the missing person records are defined as under 21 years of age. During 2020, there were 543,018 missing person records entered into NCIC. Missing Person records purged during the same period totaled 480,832. Reasons for these removals include: a law enforcement agency located the subject; the individual returned home; or the record had to be removed by the entering agency due to a determination that the record is invalid.

As of December 31, 2020, there were 8,284 unidentified person records in the NCIC. During 2020, there were 800 unidentified person records entered into the NCIC. The records entered in 2020 consisted of 530 (66 percent) deceased unidentified bodies, 12 (2 percent) unidentified catastrophe victims, and 258 (32 percent) living persons who could not ascertain their identity. In 2020, 704 records were canceled or cleared by the entering agency for reasons such as the remains being identified or the record being invalid.

The COVID-19 pandemic of 2020 has added to this challenge of resolving missing person cases for all services across the globe and has placed unique demands on the emergency services such as first responders, law enforcement, search and rescue, medical examiners/coroners. Adapting to this new landscape in the search of missing persons has added an unexpected and untested element.

Time and time again we have seen tragedy strike communities across our nation - hurricanes, floods, wildfires, tornadoes, mass shootings, pandemics and missing person occurrences. Chances are that every community has faced such a tragedy - and that they will face another in the future. The local, state, and national impact of these tragedies on families, public safety, and public health resources is astounding. With each emergency or disaster, the public safety community faces pressure to evaluate and improve training, response coordination, policies, and resources to locate and reunite families with missing loved ones.

About the Missing and Unidentified Persons Conference

People go missing for many reasons. Some people vanish due to personal choice. Others disappear because they are at risk or more vulnerable. Adults leave due to mental illnesses and personal crises. Seniors with dementia wander off. Youth run away or are thrown away. Children are abducted. Hikers get lost. People disappear in natural disasters and pandemics. Individuals are kidnapped, trafficked, and sometimes murdered. Whatever the reason, missing and unidentified persons have something in common: they have disappeared, and it is likely that someone is desperately looking for them.

Titled, "The Art of Possibilities: Finding Solutions Through Innovation and Collaboration on Missing and Unidentified Persons Cases," the 2022 conference will focus on the search and investigation of missing persons resulting from mass casualty and multiple victim incidents, featuring lessons learned from both domestic and international tragedies. It will emphasize the importance of collaboration and communication during the search and investigation of missing persons. It will offer concrete and effective evidence-based strategies, approaches, and techniques for the investigation, identification, recovery and reunification of the missing, regardless of the circumstances surrounding their disappearance. The conference will offer timely lessons-learned and strategies in the handling of missing and unidentified persons cases as a result of the

impact, challenges, and changes imposed by the worldwide COVID 19 pandemic. It will also feature innovative solutions through technology, and address complex issues relating to diverse population groups.

This annual conference attracts hundreds of domestic and international professionals from law enforcement, search, and rescue, first responders, medical examiners, coroners, missing person clearinghouses, non-profit organizations, mental health, social services, criminal justice system agencies, veteran and military service organizations, forensics, families of missing persons, and many others.
