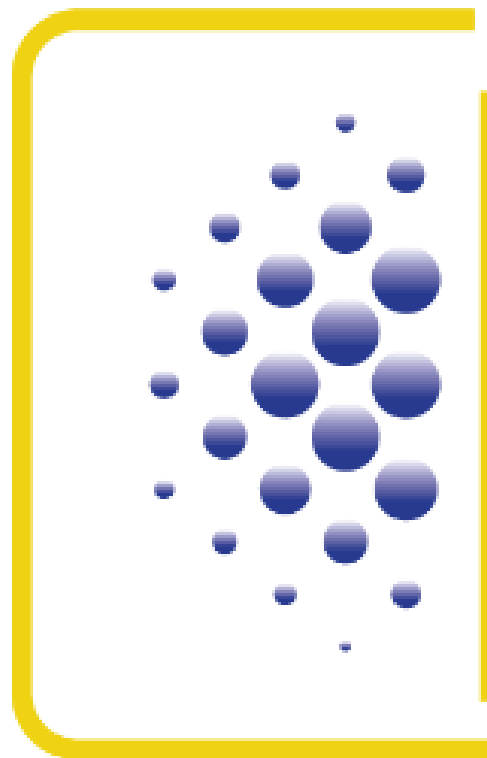

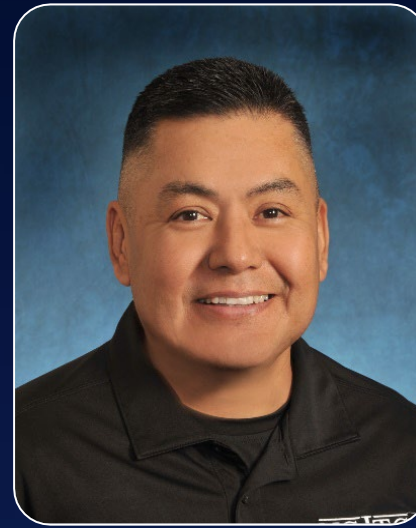

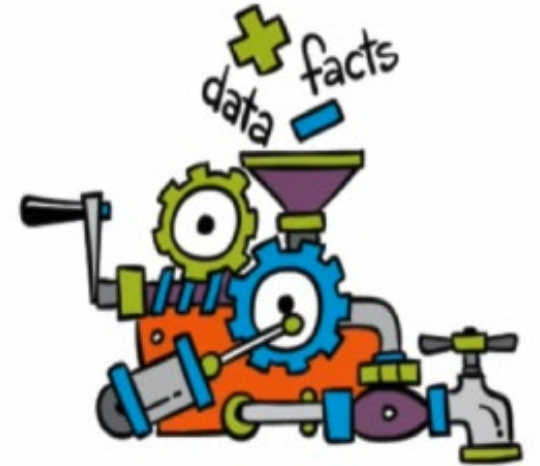

Conscious Brain

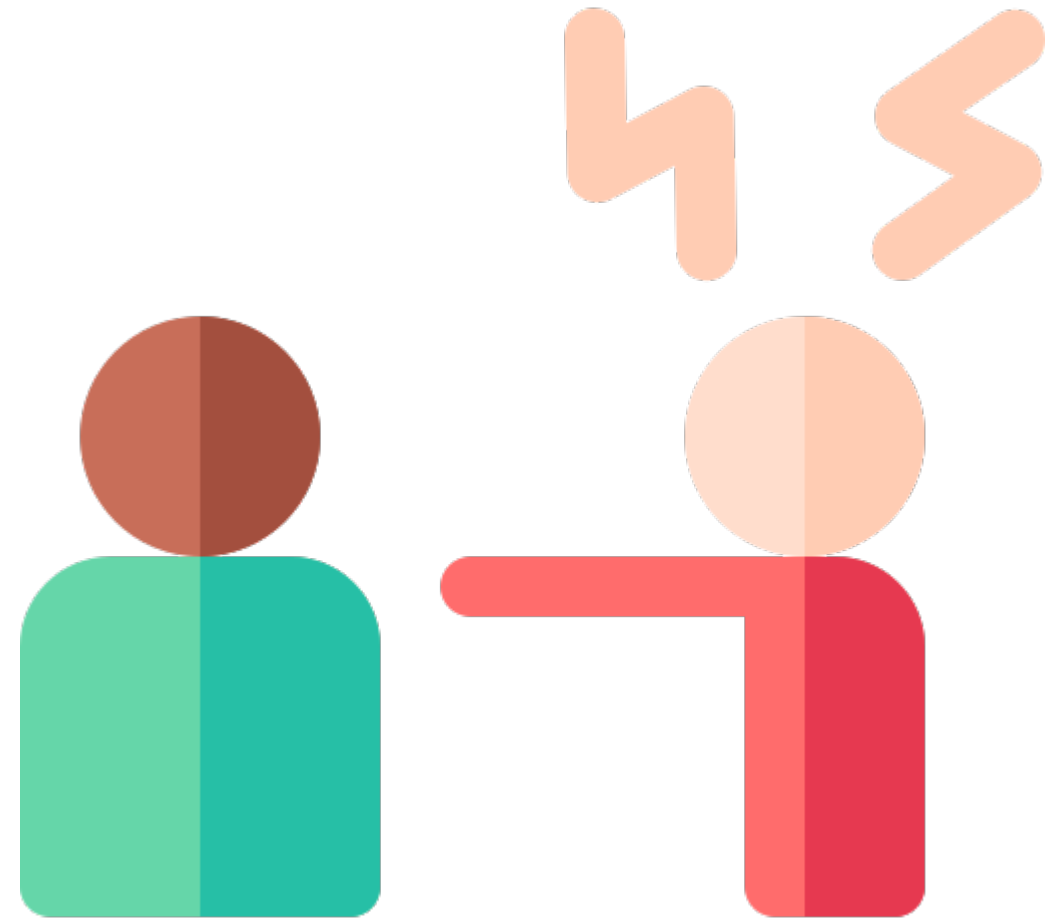


Unconscious Brain



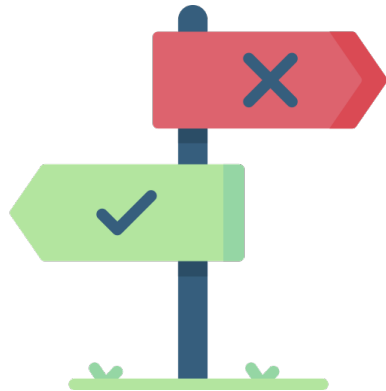
Understanding Terms

Intention versus Impact:

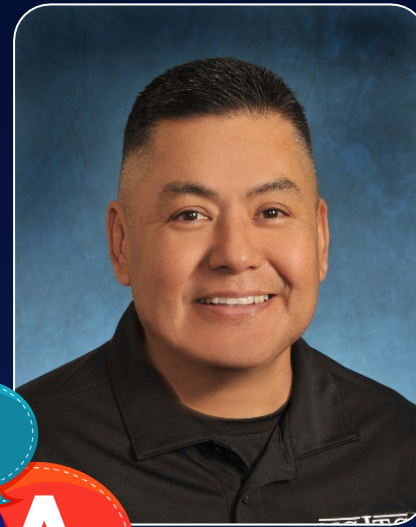
- ✓ Stay curious and engaged

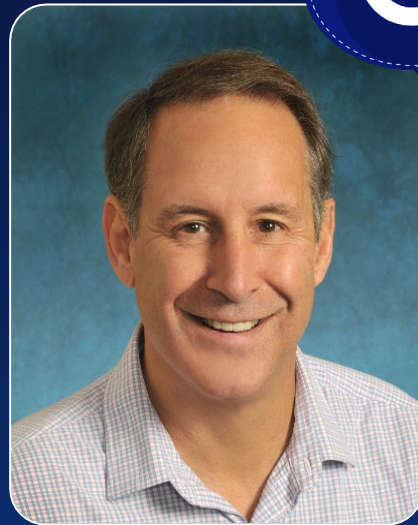
