Justice Department Observes National Missing Children's Day

Missing Children's Day is one of several projects NCJTC facilitates on behalf of the Department of Justice. This year two of our own subject matter expert instructors, Detective Jeff Rich and Detective Chris Meehan, were honored for their work on the North Texas ICAC Task Force.



On May 24, the U.S. Department of Justice honored nine people during the National Missing Children's Day Ceremony in Washington, D.C., for their extraordinary efforts to recover and help missing kids and to hold those who commit child sexual abuse and other crimes against children legally responsible for their actions. The North Texas Task Force received the Attorney General's Special Commendation for their work in processing more than 22,000 tips from the National Center for Missing & Exploited Children's CyberTipline, resulting in more than 500 arrests and the rescue of more than 50 children between November 2021 and October 2022.
