

# Tribal Corrections Capacity Building Training and Technical Assistance Program

The Tribal Corrections Capacity Building Training and Technical Assistance Program – Tribal Probation and Reentry (TPRA) provides tribal corrections and reentry professionals and Purpose Area 3 (PA3) grantees with training and technical assistance to implement culturally relevant, competent, and individualized evidence-based practices for American Indian/Alaska Native (AIAN) individuals in the corrections system.

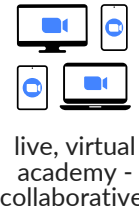
## Tribal Probation and Reentry Academy

We currently conduct a twenty (20) week virtual probation and reentry academy (Academy) for new professionals to the tribal corrections field or for professionals wanting to update their knowledge and skills. The Academy is delivered over several months on our interactive learning platform; allowing live interaction and face to face interaction from highly skilled professionals in the field, including our core staff, partnering agencies, and previous Academy graduates.

Additionally, the Academy includes live and virtual discussion sessions, resource sharing, and the requirement for both independent assignments and short check-your-knowledge quizzes each week. This rigorous academy requires at least three (3) hours per week of instruction and up to six (6) hours per week in reading, watching videos, and participating in discussions and assignments.

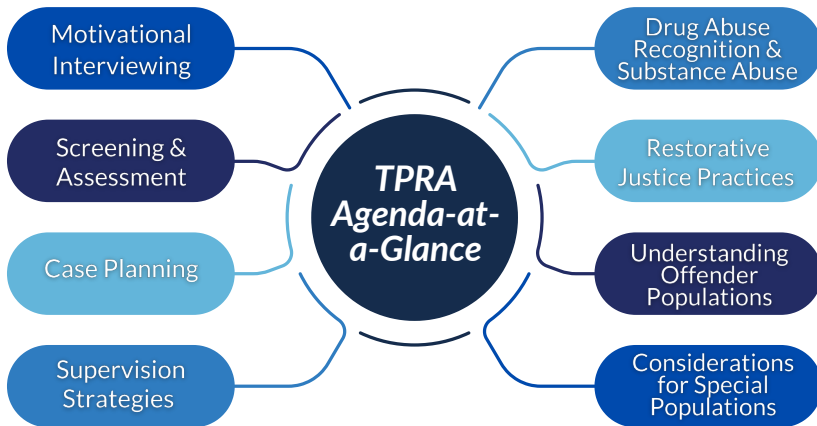

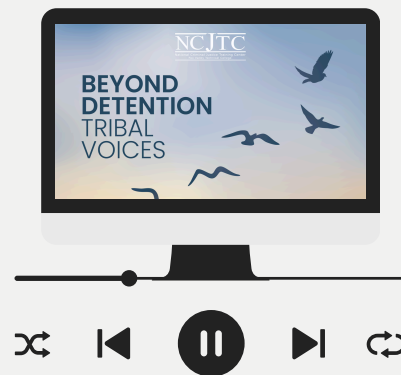
