Training Opportunities

NEW Advanced Strategies for Investigating and Prosecuting Domestic Violence

3 Day | \$425 per person

This intensive three-day training program is designed to provide advanced strategies for effectively investigating, supporting and prosecuting domestic violence cases. Participants will gain a deeper understanding of the complexities of domestic violence-related cases, including working with non-cooperative victims, assessing risk, and gathering critical evidence from the start. The course emphasizes practical skills for conducting investigations, victim support, and courtroom preparation. Through expert-led discussions and case studies, attendees will leave with actionable tools to enhance their approach and improve outcomes in domestic violence related cases.

**A companion in-service training on safety during response is also available.*

Beyond Google: Discovering Online Resources in Investigations

2 Day | \$425 per person

Examine open source online intelligence and learn how to leverage free platforms, databases, and web applications to strengthen criminal cases. Uncover little known facts and techniques to optimize results using search engines and online resources, to support your investigations and prosecutions. Learn how to complete and serve search warrants for a variety of electronic information and databases to further all types of investigations. Develop new skill sets to establish contacts and open source networks to provide ongoing criminal and threat intelligence in your jurisdiction.

Casting the Digital Footprint

2 Day | \$325 per person

Technology impacts almost every type of investigation today. Uncover the information technology users knowingly and unknowingly leave behind when accessing and using electronic devices. Learn how to covertly strengthen your investigations through gathering personal, public and open source data. Discuss techniques to locate evidence through technologies that can benefit any type of investigation.

Child Homicide Investigations

2 Day | \$425 per person

Designed with collective experience from 500+ homicide cases. Understand and build relationships between the forensic pathologist, homicide investigator, and prosecutor to successfully investigate and prosecute child homicide cases. Learn autopsy protocols, forensic essentials, the criticality of determining the cause and manner of death, interviewing and interrogation, and the role of the prosecutor in gaining appropriate convictions.

Community Approaches to Sex Offender Management

2 Day | \$325 per person

Combat recidivism and sexual violence posed by sex offenders based on management and treatment best-practices. Learn how treatment, supervision, law enforcement, and the community at large can increase the offender's chances of a pro-social non-offending lifestyle. Explore response strategies for adults and juveniles who commit sexual offenses.

Conducting Comprehensive Security Surveys

3 Day | \$425 per person

Explore the elements of conducting successful comprehensive security surveys and design for businesses, government offices, college campuses and schools, houses of worship and residences within your community. Focus will be on developing organizational, mechanical, and natural security measures. This course relates to law enforcement, security officials, architectural design specialists and other government officials looking to improve security in their community buildings.

Creating a Safer Courthouse: The People, Places and Things

3 Day | \$425 per person

Courthouses serve as vital centers of government and community life, making them frequent targets for both calculated and impulsive acts of violence. Unfortunately, despite these clear risks, court security is often overlooked. This course is designed to counter such threats by enhancing staff readiness, learning to conduct thorough physical security assessments, rigorously enforcing safety protocols, and establishing specialized protective security teams. Crafted for both newcomers to court law

enforcement and seasoned professionals looking to sharpen and extend their skill sets, the program offers flexible security strategies that can be adapted for a wide range of judicial settings—from municipal and tribal courts to more formal state-level systems.

Criminal Connections: Child Exploitation Material and Child Sexual Abuse

2 Day | \$425 per person

Explore investigative strategies that address the relationship between child sexual abuse and child sexual abuse materials (child pornography) to supplement an investigation and corroborate victim statements. Gather new tools and resources for the most comprehensive case outcomes.

Current Drug Trends

2 Day | \$225 per person

Gain an understanding of the stages of use, addiction, and withdrawal symptoms of using drugs. Discuss common delivery systems and observe examples of emerging drugs in various forms. Learn how to recognize the signs and symptoms of drug usage, as well as how Naloxone/Narcan works in cases of opioid overdoses.

Enhancing Investigations through Genetic Genealogy

2 Day | \$325 per person

Explore and discuss the application of Forensic Genetic Genealogy (FGG) and how it aids in investigations. Techniques instructed include tips in using genealogy to help establish the identities of cold case suspects and assist with identifying human remains. Instruction is provided by experienced investigators who have gained expert knowledge in the application of FGG through real-life cases. Discuss topics including FGG techniques, investigative strategies for developing leads and information, as well as working with private labs and other related resources.

NEW Evolving Strategies in the Fight Against Trafficking

3 Day | \$425 per person

This three-day course explores evolving trends in human trafficking and practical strategies for prevention, intervention, and prosecution. Participants will examine risk factors, investigative approaches, victim support strategies, the role of technology in investigations, and community-based

solutions. Special focus is given to strengthening investigation and prosecution efforts. Through case studies and collaboration exercises, attendees will develop actionable plans to enhance multi-disciplinary responses in their own communities.

Note: While some discussion will address child sex trafficking, the primary focus of the course is on adult labor and sex trafficking.

Fire and Explosion Related Death Investigations

2 Day | \$325 per person

Join other investigators to gather new information and tools for investigating fire and explosion related deaths. Examine the principles of fire behaviors, areas of focus in fire related deaths, working with the medical examiner's office and evidence/scene safety considerations.

Investigating and Prosecuting No Body Homicides

2 Day | \$425 per person

Gather the investigative tools needed to build a prosecutable homicide case and take it to trial without a body being recovered. Explore why missing persons' cases should be investigated as homicides, until discovered otherwise.

Investigation and Prosecution of Cold Case Homicides

2 Day | \$425 per person

Improve investigative techniques and prosecutorial efforts needed to successfully decipher unresolved and cold cases. Explore essential investigative, forensic and prosecution methodologies through the dissection of actual cases, best practice examples, interactive discussions, and contemporary resources. Learn proven strategies to avoid complications that are detrimental to the prosecution of cold cases. Discuss practices relevant to the establishment and maintenance of an efficient cold case unit.

Managing the Media Message: Your Agency's Story and How You Tell It

2 Day | \$225 per person

Law enforcement agencies have faced major public and media scrutiny in how public safety situations are managed in their communities. Building strong relationships with key supporters and the media BEFORE a crisis occurs will open lines of communication during adverse situations. Learn how agencies can best tell their story, from building positive messaging, crisis communications, or providing continuity of operations following an incident.

Mobile Device Investigations

3 Day | \$425 per person

Learn current mobile phone related strategies and techniques for any type of investigation. Explore and apply practices for working with cellular network providers, completing technology-focused search warrants, analyzing cellular provider call data, associating reported data to the investigation and effective case reporting strategies.

NCJTC Death Investigation Academy

5 Day | \$625 per person

Explore strategies for conducting death investigations under several origins. Learn how to evaluate the crime scenes, conduct effective interviews and interrogations, develop case leads, utilize investigative resources (crime laboratories, medical examiners), and comprehend medical autopsies.

NCJTC Sexual Assault Investigation Academy

5 Day | \$625 per person

Explore strategies for conducting comprehensive sexual assault investigations. Learn how to support victims, gather and maintain evidence, manage crime scenes, conduct effective interviews and interrogations, utilize investigative resources (SANE nurses and support services), and prepare cases for prosecution.

Organizational Resiliency Starts with You!

2 Day | \$325 per person

Discover the relationship between self-care and organizational resilience. Organizational resiliency promotes an inclusive work environment, strengthens employee retention, and improves workplace satisfaction. Gain strategies to understand, assess and support work culture and morale. Explore how ethical leadership influences a resilient culture and how a focus on self-care impacts organizational effectiveness.

Preparing for Critical Events: Planning, Response & Recovery

2 Day | \$325 per person

Community events come in all shapes and sizes. Nationally, communities face events and related threats that demand preparation, response, and recovery planning. This course will cover identification of threats; assessment of sites; planning for and response to multiple threats (i.e., manmade and natural events); and recovery from critical incidents.

Protecting Children in a Digital Age

1 Day | \$225 per person

Technology plays a tremendous role in our children's lives. Learn about the ways children are interacting online to create better understanding and open up meaningful communication. Increase awareness of opportunities to protect and connect with children while also gathering valuable information to mitigate threats posed by individuals who seek to exploit them.

Reimagine Policing: Strategies for Building Community Relationships that Last

2 Day | \$225 per person

Gain insight and strategies to maximize how police agencies can connect with their community and stakeholders through dialog and partnerships. Consider minority perceptions of policing due to historical events and ways to overcome these barriers. Discover strategies for creating a "learning organizational culture" while appreciating the fragile relationship with our communities. A focus will be on the importance of police legitimacy through ethics, empathy and equity.

Sex Offender Registration and Notification

2 Day | \$325 per person

SORN programs typically experience significant challenges related to staff turnover, inadequate resources, court challenges, and lack of skill development opportunities. Whether you are new to this area of work or have are experienced, join us for an intensive two-day skill development training designed specifically for SORN personnel. During the training, we will cover an introduction and overview of SORN laws, registration of offenders, community notification to the public, and enforcement and compliance issues. Advanced skill



development such as registrant monitoring and compliance, and community notification meetings will also be covered. Participate in this interactive training which includes educational information, ready-to-use resources, case studies, interactive discussion, and opportunities to apply learned skills.

Sexual Offenses: Mind & Motivation

2 Day | \$325 per person

Gain an introduction into the psychology, or mindset, of those that commit sexually motivated crimes. Learn about sex offender typologies and patterns of behavior. Explore the relationship between paraphilia and criminal acts. Review and dissect real case examples to gain insight into offender modus operandi. Knowledge obtained can be applied during interview and interrogation to help resolve sexually motivated cases.

Strategies for Instructional Excellence

3 Day | \$425 per person

Develop and enhance the skills of the 21st Century criminal justice instructor. Examine how adults learn and explore effective instructional methods. Develop a structured learning plan, apply adult-learning techniques, utilize instructional technology, evaluate learner retention strategies, and the legal implication of instruction.

Students First! Making an A+ Impact

1 Day | \$225 per person

Transform your instructional approach to training! Learn how to demonstrate and apply techniques to maximize your instructional effectiveness. New and even senior instructors are confronted with evolving instructional challenges and requirements; explore a variety of solutions to meet these challenges. Prepare for a student-focused immersion into the art and science of instructional excellence.

Suspicious Death Investigations: Finding the Right, Eliminating the Wrong, and Avoiding the Undetermined

2 Day | \$325 per person

Examine case studies based on the experience of a homicide detective and forensic pathologist. Identify key scene findings and correlate findings to the autopsy results. Analyze communication methods between the investigating agencies and the medical examiner's office. Learn how unique case findings can affect the investigation. Discuss case resolutions and lessons learned.

Verbal De-Escalation & Conflict Resolution

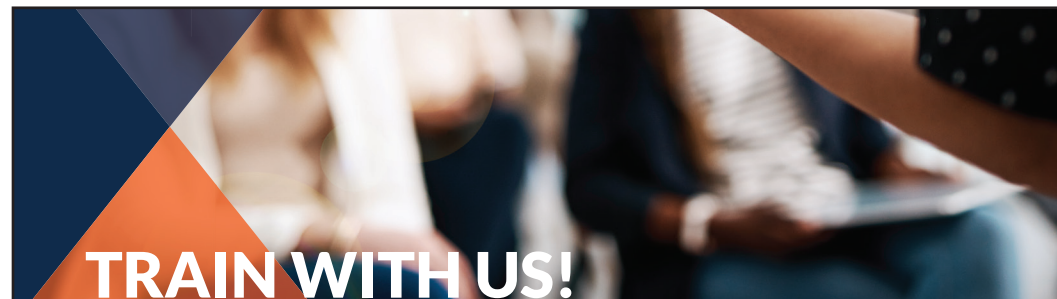
1 Day | \$225 per person

The ability to organize your thinking and calmly respond can help you avoid a potential crisis. Every year, around 1000 people are shot and killed by police. Five hundred of them wielded a gun while the rest of them held knives, toy weapons, or no weapons at all. Learn how de-escalation communication skills can defuse those situations and lead to more successful resolutions.

What Are They Running From? Youth Trauma & Adverse Childhood Experiences

2 Day | \$325 per person

Discuss why juveniles runaway and dangers that apply to youth during this time. Explore strategies to interrupt chronic runaway behavior, while providing a tool to help assess and document runaway reasons, behaviors, and intervention options. Consider trauma that can occur during runaway events and approaching youth during traumatic events.
